

CITY OF JOSEPHINE, TEXAS
ORDINANCE 2024-09-09

AN ORDINANCE OF THE CITY OF JOSEPHINE, TEXAS, DECLARING UNOPPOSED CANDIDATES FOR MAYOR AND COUNCILMEMBER PLACE 5 ELECTED TO OFFICE; CANCELLING THE NOVEMBER 5, 2024, CITY COUNCIL ELECTION; REQUIRING ISSUANCE OF A CERTIFICATE OF ELECTION TO EACH CANDIDATE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, an election was called for November 5, 2024, to elect a Mayor and Councilmember Place 5, and

WHEREAS no proposition or opposed at-large race appears on the ballot and the City Secretary has certified that there is only one candidate for Mayor and only one candidate for Councilmember Place 5 and that, therefore, each candidate is unopposed, and

WHEREAS no candidate's name has been placed on a list of write-in candidates for any office under applicable law, and

WHEREAS the City Secretary has delivered a Certification of Unopposed Candidates (Exhibit "A" attached) to the City Council,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JOSEPHINE, TEXAS:

SECTION 1. The City Council finds that the above stated premises are true and correct.

SECTION 2. The unopposed candidates for City Council listed below are hereby declared elected, to wit:

Jason Turney, Mayor, for a term of two years, and

Gary Chappell, Councilmember Place 5, for a term of two years.

SECTION 3. The City Secretary is directed to issue a Certificate of Election to each of the above-named members of the City Council in the manner and at the same time as provided for a candidate elected to office at the election. Each person elected must qualify for the office in the manner provided by the Texas Constitution.

SECTION 4. November 5, 2024, General Municipal election is cancelled.

El 2024 Election**SECTION 5.** This ordinance shall take effect immediately from and after its passage, as the law in such cases provides.
